The Mayenne regional health system picks CegedimLogiciels Médicaux's certified Solution MSP software

A collaborative platform for multidisciplinary practices

Cegedim Logiciels Médicaux (CLM), medical software publisher and service provider to general practitioners and specialist doctors, announces that its platform for multidisciplinary health facilities (MSPs) has been in place at the Mayenne regional health system (*Pôle de Santé Libéral du Pays de Mayenne*, in the Mayenne Department) since January. This new contract win is part of a ramp-up in sales momentum since the start of the year and confirms that CLM's Solution MSP software is well suited to the needs of these rapidly growing regional health systems, which are part of an effort to tackle the issue of medical deserts, and to improve access to care and care coordination.

All 68 of the healthcare professionals in the multi-site Mayenne system, which is spread across several cities and clinics in the department, are participating in the project to overhaul the center's IT system.

A secure, mobile fully web-based solution

For its 26 doctors (general practitioners and specialists) and 42 support staff (nurses, pharmacists and allied health professionals), the Mayenne regional health center wanted a fully web-based solution that is scalable and complies with ASIP Santé health information system guidelines. The system they have chosen fits in with the way individual users operate and run their practices, and notably provides needed mobility, while also making it easier for professionals to coordinate their efforts by using simple, secure tools.

CLM's *Solution MSP* was exactly what they were looking for. A collaborative platform specifically designed for multidisciplinary practices, it has earned government agency ASIP's e-Santé certification for health clinic and medical center software. This guarantees that the solution performs all of the functions needed to coordinate care and protect the confidentiality of patients' health records.

Eligible for the new *Règlement Arbitral* scheme

Using the CLM solution will also allow healthcare professionals to qualify for the new *Règlement Arbitral* scheme¹.

By working closely with its clients, CLM designs customized solutions for each MSP. It collaborates with Cegedim's allied health and pharmacist computerization units, *RM Ingénierie* and *Smart Rx*, from the start. This combination of expertise allows CLM to ensure that its functionality is pertinent, easy to use, and flexible.

Professional users can choose which applications are best suited to their practice – for example, the *MLM Mobile Edition* smartphone app lets nurses working remotely to upload information needed for coordinated care – and adapt their selection over time. The tools used in the solution communicate with each other, making it easier to work as a team, work remotely, and confidentially share information via the MS Santé-certified secure messaging system.

¹ The *règlement arbitral* regulation took effect on February 27, 2015. It deals with local health clinics and is designed to codify new forms of compensation for independent healthcare professionals working as a team.

The Mayenne regional health system comprises 68 healthcare professionals: 17 general practitioners, 9 specialist physicians (2 dermatologists and 7 radiologists), 24 nurses, 2 physical therapists, 2 podiatrists, 1 dietician, and 13 pharmacists.

In order to serve patients throughout the department, the system has locations in Mayenne, Oisseau, Ambrières, St Fraimbault de Prières, Jublains, Aron, Moulay, and St Baudelle.
