French authorities continue to tighten the country's transparency rules and "anti-gift" provisions, known as DMOS laws. The trend is forcing drug and medical equipment companies to be incredibly vigilant. The stricter regulations are creating additional administrative work, for example with the initial application of several new measures in the months ahead: the "Sunshine Regulations" decree published in the Official Journal (JO) on December 30, 2016, dealing with benefits disclosures; the new "anti-gift" rules published in the JO on January 20, 2016; expanded rules on disclosing remuneration and benefits in the Animal Health segment; and so on.



With this in mind, Cegedim has drawn upon its expertise in the fields of health and business processes to create an original administrative solution for life science companies. The **TPO - Transparency Process Outsourcing** offering gives companies a dedicated back office team to track every stage of a project and verify regulatory compliance.
