

## **CEGEDIM ANNOUNCES THE ACQUISITION OF FRENCH COMPANY 01 SANTÉ**

**Paris, 9 June 2008** – Cegedim SA subsidiary Cegedim Logiciels Médicaux (CLM), software publisher and service provider to the medical profession, announces the acquisition of 01 Santé SA, publisher of “MegaBaze” medical software.

**01 Santé occupies a strong position in the oncology field with its OncoBaze software, which is used by nearly 70 clinics in France, including 25 that rank among the country's largest. OncoBaze was notably chosen to equip the chemotherapy departments of Générale de Santé's clinics.**

The deal was signed on 21 April 2008 and will be financed with equity. The businesses included in the deal represent annual revenues of around €705 K and will have a positive impact on Cegedim Group's 2008 half-year accounts.
