At the meeting, Cegedim will also confirm:

- Its expectation for 2017 of like-for-like revenue growth of slightly more than 6.0%, and EBITDA in a range of €66.0 million to €72.0 million inclusive.
- **That the process of divesting its Cegelease business** is ongoing and that a sale is planned in the first quarter of 2018, although there is no guarantee a sale will take place.

The above outlook does not reflect the potential divestments of *Cegelease* and *Eurofarmat*.
