### Detection of covid-19 cases in primary care: GERS Data reports a slowdown in the detection of new cases

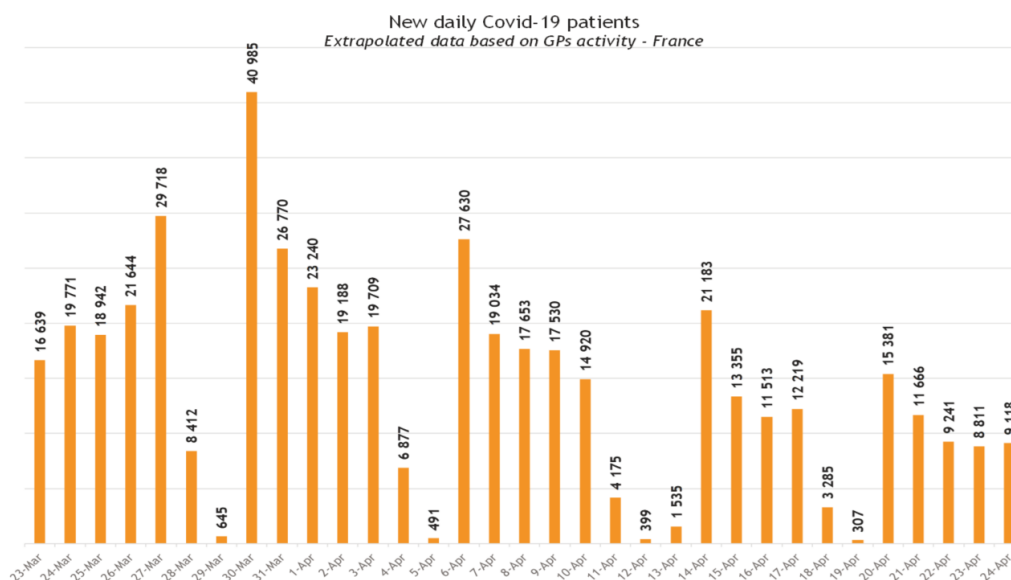

The evolution of COVID-19 diagnoses below helps to understand what the situation could be as of May 11, the date of the gradual phase-out of containment.

Although the number of new cases of COVID-19 identified by general practitioners in France continues to decrease, this decrease nevertheless seems to be slowing down, as shown in the figures in the tables below.

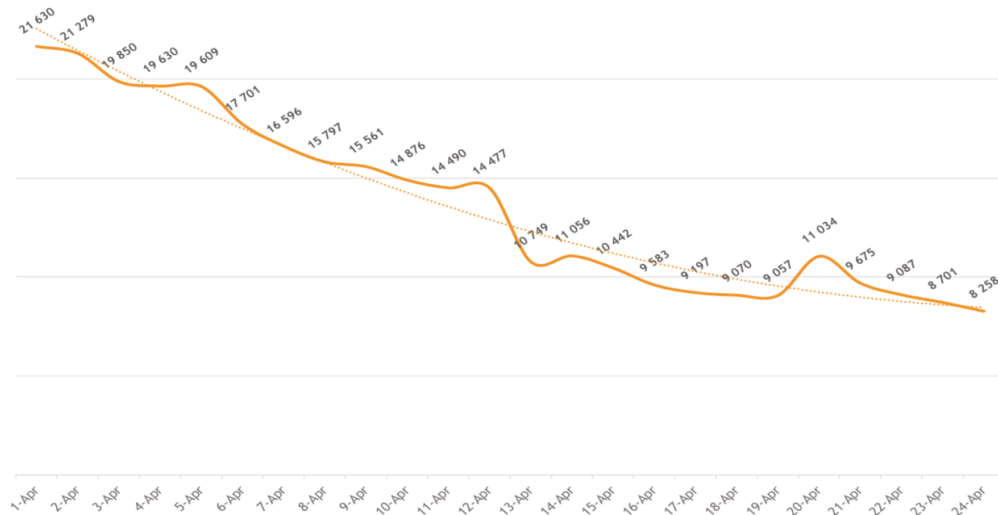
